

## Memorandum of Understanding & Non-Disclosure Agreement

Between

and

**CMR Technical Campus**

This Memorandum of Understanding entered into on ..... at Hyderabad between **Rulepaper Academy** function unit of Techclyde Services Pvt. Ltd having Principle office located at 530/A, Sai Ram Plaza, 19<sup>th</sup> Main Rd, Sector 3, HSR Layout, Bengaluru, Karnataka 560102. & **CMR Technical Campus** (CMRTC) located at Village Kandlakoya, Medchal, Secunderabad, Telangana 501401. Hereinafter Rulepaper Academy will be referred as **Company** & CMRTC will referred as College.

With mutual discussion & agreements both parties have decided to jointly work on subjects mentioned below but not restricted to:

### A) Rulepaper Cloud Computing IaaS Projects

#### Minor Projects -

- 15-20 days program
- 4 students per project
- Projects on Cloud Computing IaaS

#### Major Projects -

- 30-45 days program
- 4 students per project
- Projects on Cloud Computing IaaS

### B) Faculty Development Program for 2 days on Cloud Computing.

Both the parties had preliminary discussions in this matter and have ascertained areas of broad consensus. Both Parties have therefore, agreed to enter in writing these areas of consensus, under a Memorandum of Understanding & NDA.

This Memorandum of Understanding implies the concord between both parties where college will be responsible for candidates' enrolment. Primarily these courses will be designed and framed by company & hence IPR of these entire course will remain with the company.



Now this Memorandum of Understanding witnesses that:

### Commercial:

- Minor projects

- Faculty Development Program for 2 days.

### Payment Terms:

1. For the Projects payment has to be made in advance and the enrollment should be made for the both the project payment at once or complete payment for the minor project and 50% advance for the major projects.
2. For Faculty Development Program the payment has to be made in full before commencement of the program.
3. For any program commencement whether project or FDP, the payment has to be made seven days prior to the program start date.

### General Terms:

Confidential Information- Any information like business strategy, document, training plan, courseware, outline, client name and client business strategy will be consider as confidential information & shall not be share with any third party without prior mutual consensus between both the parties.



Lab Requirements - College must provide desktops or students must have laptops with 4GB. RAM, 64bit architecture, internet with speed of 2mbps minimum and 100 GB free HDD with virtualization enabled at hardware level.

Intellectual Property right (IPR)- IPR of training delivered by company or to be delivered by company through CMRTC client will remain with company. CMRTC will only hold Marketing rights for training portfolio to be delivered by company with prior mutual consensus on time to time basis.

All financial will remain highly confidential between both the parties & will not be disclosed to any third party without prior intimation among the parties herein.

The agreement imposes no obligation upon either of the parties with respect to confidential information that becomes a matter of public knowledge through no fault of reseller.

Period of this MOU is for 3 years from day of Signing off the agreement which will be renewed for further period of 3 years with mutual discussion.

The commercials will vary as per market situation for each specific project commencement or during the period of association.

Termination: This MOU can be terminated by either party with prior notice of 60 days.
