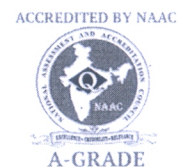

In the reference 2nd cited, the UGC has conferred Autonomous Status to CMR Technical Campus, Kandlakoya (V), Medchal (M&D), Hyderabad, affiliated to JNT University Hyderabad, Kukatpally, Hyderabad, Telangana under the UGC scheme for Autonomous Colleges for a period of ten years with effect from the academic year 2019-20 to 2028-29 and requested the University to issue conferment orders as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations 2018 for Autonomous Colleges. The college, if eligible, shall apply for grant of autonomy as per the norms laid down in the Regulations.

Further, the UGC has stated that the autonomous college shall abide by all the provisions of the UGC Regulations for Autonomous Colleges. The college shall also apply in the prescribed format to the UGC for extension of autonomous status six months prior to the expiry of the autonomous cycle.

Hence, the Vice-Chancellor is pleased to approve the conferment of Autonomous Status to CMR Technical Campus, Kandlakoya (V), Medchal (M&D), Hyderabad under the UGC scheme for Autonomous Colleges for a period of ten years with effect from the academic year 2019-20 to 2028-29. Further, it is to inform you that to follow existing University syllabus & regulations for 2019-20 admitted batch and can be revised autonomous syllabus from 2020-21 admitted batch onwards.
