MEMORANDUM OF UNDERSTANDING (MOU)

THIS MEMORANDUM OF UNDERSTANDING (MOU) made and executed on this 17th day of July, 2014 year BETWEEN:

Soft merge solutions pvt Ltd., a company registered under the Companies Act 1956 and having its Registered Office at Plot No. G2 Bishan apartments, Beside SBH, Srinagar colony, Hyderabad – 500 082 and represented by Mr K.SRINIVAS RAO its Managing Director, here in after referred to as SMS, which term shall mean and include, unless repugnant to the context and meaning thereof, its Successors, Legal Representative and Assigns, Of the **FIRST PART**;

AND

Electronics and Communication Engineering (ECE) of CMR Technical Campus (CMRTC), Kandlakoya (V), Medchal Road, Hyderabad- 501401

WHEREAS, CMRTC is a Company involved in Students Project and training / design and development of product relating to d Computers, Wireless data communication, electronics products and related software solutions.

Embedded Applications: Low level Embedded System Design: 8/4 bit Micro-controllers / Micro-Processors, ALP & Embedded C
Advanced Embedded System Design: 16 / 32 bit RISC/CISC Micro-Controllers/Micro-Processors & RTOS

Design Methodologies : Embedded Architecture Design for H/W & S/W;
Debugging Methodologies : H/W, S/W (ALP & Embedded C/C++) & Co-Simulation
CAD/CAE Tool : Design Editors, Cross Assemblers, Cross Compilers, ISF & IDEs Debuggers (ALP/EC/EC++/Hard Ware) and RTOs.

Languages : ALP for 8bit/16bit/32bit processors/Controllers; C/C++ and Embedded C/C++

Domains:

Presently working on various Domains Like Micro Controllers, Micro processors, Arm based embedded systems and softwares viz., C, C++, Java, VB, .Net, Windows and Linux based platforms and technologies.

WHEREAS CMRTC is in the field of education, imparting knowledge to students aspiring to be Engineers and Technologists.

AND WHEREAS, both **SMS** and ECE, CMRTC have agreed to form a '**STRATEGIC ALLIANCE**' for providing industrial inputs to the Engineering students for mutual benefit.

AND WHEREAS on the faith and strength of such representation and warranty, both **SMS** and CMRTC have agreed to enter into this Memorandum of Understanding as per the mutually agreed clauses as mentioned below:

1. Provision of Supplies and Services:

CMRTC shall provide required facilities and qualified personnel to impart training as mutually agreed to and each personnel shall perform to the best of his/her ability during the term of the contract; Likewise, **SMS** shall make available their facilities for special projects and also for Training of **CMRTC** personnel. In addition, **SMS** shall depute their experts for necessary training at **CMRTC** and depending upon nature and degree/ level of specialization, **SMS** shall train faculty and students of ECE, CMRTC on selected topics. All decisions under this clause will be taken between the parties hereto only after prior consultations. Training will be conducted at mutually convenient dates.

ECE, CMRTC shall provide infrastructure as required by the company for conducting training, lectures etc., and allot faculty members of the Institute to undertake faculty level R&D work proposed by **SMS**, with due compensation.

SMS shall impart training on core areas such as Micro Controllers, Micro Processors, Arm Processor, and Wireless applications like LPR/GSM/GPRS based embedded systems and soft wares viz., C, C++, Java, VB, .Net, Windows and Linux based platforms and technologies.

SMS shall deliver special lectures on advanced topics. The Company agrees to conduct value added courses for students & Faculty at competitive rates to the institution.

2. Scope of Activities:

- 1) To give training capsule to a limited number of students/ Semester or industry-based projects in the above mentioned fields.
- 2) To offer special lectures by experts on topics pertaining to the above fields on mutually convenient dates
- 3) To go in for formation of expert panel by pooling in the expertise of SMS with that of CMRTC for conducting seminar /conferences on the emerging trends in the above mentioned fields.
- 4) CMRCET to make available the infrastructure as required by SMS for conduct of training lectures etc.,

3. Fees

For supplies and services availed by either party to this **MOU** from the other contracting party, there shall be billing by the service provider in the form of purchase order which shall contain necessary details like nature and quantum of service rendered. In the case of training of personnel of technical background and number of such personnel, duration of training and fees are to be mutually discussed and decided between the parties in each case, well in advance.

4. Non- Exclusive relationship:

This agreement is non-exclusive in nature and both **SMS** and CMRTC shall retain their right to perform their obligations with any other party during the term of this **MOU**.

5. Independent Contractors:

SMS and ECE, CMRTC hereby agree that each is an independent contractor and this **MOU** doesn't mean that one is an agent of the other or of each other, and neither party shall be entitled to bind, by its acts, omissions or otherwise, the other party.

7. Entire Agreement:

This instrument sets forth the entire agreement between the parties hereto and either party shall deem all other representations, irrelevant and unenforceable. All modification to this Agreement shall be in writing and only if mutually agreed to.

8. Term of MOU and Notice of Termination:

This **MOU** is open ended in nature; but can be terminated with a month's notice on either side given to the other party in writing at their addresses mentioned at the top/any other address to be notified in future. Such notice shall be deemed to be properly given if sent by registered post or by courier to the persons authorized to sign this **MOU**.

9. Authorized Representatives:

Both parties hereto declare that their duly authorized respective representatives shall execute this agreement.
