5. Entire Agreement:

This instrument sets forth the entire agreement between the parties hereto and either party shall deem all other representations, irrelevant and unenforceable. All modifications to this agreement shall be in writing and only if mutually agreed to.

6. Term of MOU and Notice of Termination:

This MOU is open-ended in nature, but shall remain valid for a minimum three years and can be terminated only for the second academic year with three months notice on either side given to other party in writing at their address mentioned at the top/any other address to be notified in future. Such notice shall be deemed to be properly given if sent by registered post or by courier to the other persons authorized to sign this MOU.
