2. An Expert Team conducted on-site evaluation of the programme during 23rd to 24th July, 2016. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The Programme has been granted Provisional Accreditation. CMR Technical Campus, Kandlakoya (v), Medchal (M), Ranga Reddy Distt., Hyderabad-501401, Telangana should submit the Compliance report at least 6 months before the expiry of validity of accreditation mentioned above. It may require submission of pre-qualifiers before sending the Compliance report for granting further Accreditation.

5. The accreditation status awarded to the programme as indicated in the above table does not imply that the accreditation has been granted to **CMR Technical Campus, Kandlakoya (v), Medchal (M), Ranga Reddy Distt., Hyderabad -501401, Telangana** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.

If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
