Study programs with a limited admission	According to § 10 of the regulations for granting university places, the letter of admission to study programs with a limited admission is invalid if the deadline of enrolment has not been observed.
Registration period	The registration period for students aiming to enrol for the winter semester at the University of Koblenz runs until the 19.10.2025 , for the summer semester until the 05.04.2026 .
Missing documents	In case of the conditional admission to the University of Koblenz: Please make sure to provide the missing documents during enrolment at our university, at the latest. Otherwise your letter of admission will become invalid.
Visa requirements	As a Non-EU-Citizen you most likely need a student visa for the enrollment at the University of Koblenz. You cannot be enrolled at our university on a tourist visa. Information on visa regulations is available at the German embassy or consulate in your country of residence.
Health Insurance	To study in Germany you need to obtain a valid health insurance issued by a German health insurance provider – or in certain cases an exemption therefrom. It is possible to sign a contract for your health insurance upon your arrival in Germany.
Costs of Living	Please keep in mind that all costs of living must be covered by you.
Important note	Incomplete or false information will lead to the withdrawal of this letter of admission.

Enrolment

Following documents and information have to be provided for the enrolment to the Registrar's office at <study@uni-koblenz.de> (19.09.-19.10.2025 for the winter term, 05.03.-05.04.2026 for the summer term):

1. **Copy of the first page of your admission letter**
2. **Copy of the visa & APS (if applicable)**
3. **Copy of your flight ticket**
4. **Confirmation of payment in amount of € 327,30** (subject to adjustment). The amount includes contributions to the Studierendenwerk, the Studierendenschaft (AStA) and the UniCard (student ID).
5. **Electronic proof of compulsory health insurance (SMV):**
The University of Koblenz accepts only electronic reports from the statutory health insurance companies. Therefore, please request confirmation from your insurance company (M10 notification). The sender number of our university is H0000289.

Do not provide your health insurance card.

Privately insured persons must also contact a statutory health insurance company. In this case, the statutory health insurance company will check whether you are exempt from compulsory insurance and, if so, will send the electronic notification. Enrollment is not possible without the electronic proof.

6. Certified copy of the ex-matriculation certificate from all the attended educational institutions in Germany, in case you have been enrolled at any German university in the past. The ex-matriculation certificate should indicate your name, reason for ex-matriculation, period of studies and the name of the study program. The procedure of enrolment is different and takes longer, please contact us well in advance.

Please do not provide any originals, they will not be returned. In case of missing or incomplete documents the student cannot be enrolled.
