

MEMORANDUM OF THE SOCIETY

1. Name of the Society : C.M.R. TECHNICAL EDUCATION SOCIETY
2. Location of the Office : Plot No.33, Jayanagar Colony, Bowenpally, situated Secunderabad-11, Hyderabad Dist.
3. Aims and Objects:
 - a) To further the fine moral and cultural traditions of secular India through imparting education to childrens/students in the Educational Schools, Colleges, Institutions specially started by the Society.
 - b) To organise and promote the study of Science, Humanities, Fine Arts, Computers Science or other courses in the context of developing India.
 - c) To train and prepare selected students so that they may excel in their choosen fields/courses/programmes.
 - d) To establish Schools, Junior, Degree, Engineering, Management, I.T.I., Technical, Business Schools, Information Technology, Medical Colleges and other Educational Insitutions and run the same for no profit and no loss basis for the progressive realisation of the objectives of the Society.
 - e) To establish self employment units for unemployee youth on no profit and no loss basis.
 - f) To work for protection of environment, development of greenary etc.
 - g) To protect the Sovereignty & Integrity of the Nation and work for development of secular values, brotherhood and tolerance among the different sections of the Society.
 - h) The funds of the society shall be spent for the attainment of aims and objects of the Society and raise loans from Financial Institutions, banks etc by creating charge over the assets/property of the Society.

DOCUMENT NO. II
RULES AND REGULATIONS

- 1) Name of the Society : C.M.R. TECHNICAL EDUCATION SOCIETY
2. Location of the Office : Plot No.33, Jayanagar Colony, Bowenpally, situated Secunderabad-11, Hyderabad Dist.
- 3 Admission : The School/College shall admit both boys & girls.
 - i) Membership : Membership is open to all who are interested in furthering the aims & Objects of the Society
 - 1) The Governing Council shall consists of Seven members
 - 2) There shall be no category of members.

RIGHTS & DUTIES OF THE OFFICE BEARERS:

CHAIRMAN:

- i) In addition to above, he shall preside over the meetings of the Governing Council and conduct the programmes. He can supervise all branches of the Society. He can cast his vote in the case of tie.
- ii) In case of emergency, he shall call a meeting of member of Governing Council in writing within 24 hours notice.
- iii) He shall advise in the matters relating to the Society established schools/colleges and shall act as a Correspondent on behalf of the Society.

VICE PRESIDENT

He shall assist the Chairman in discharging his functions. In the absence of the Chairman she will perform the duties of the Chairman as entrusted by the Chairman.

SECRETARY-CUM-CORRESPONDENT

- i) She is the Chief Executive officer of the Society and custodian of all records relating to the Society. She shall be responsible to the Governing council for all the matters relating to the Society.
- ii) She has to take on record all minutes of the Society and convene meeting of the Governing Council.
- iii) She shall make necessary arrangements including full time or part time appointments in the Society with consultation with the Principal of School, Colleges, Institutions etc. and the Chairman, which shall be confirmed in the following meeting of the Governing Council.
- iv) She shall advise the treasurer in preparing the budget and expenditure, statements to put before the General Body for its approval.

v) She shall arrange to collect and receive all moneys including donations from the Donors and Deposit in the Account of the Society within 48 hours.

vi) She shall have the powers to negotiate any arguments for lease/rental/purchase /sale of any property for the benefit of the Society and shall execute the same on behalf of the Society. She is also authorised to approach the Banks, Financial Institutions for raising loans by creating charge over the assets of the Society for the purpose of the development of the Society.

vii) She shall negotiate, sign and execute all official documents, agreements, affidavits, undertakings, deeds, declarations or whatsoever in the matters/transactions relating with Government Officials, Private Persons, Financial Institutions, Bank etc. in respect of the Society.

JOINT SECRETARY

She had to do the work as entrusted by Secretary. He/She has to assist the Secretary in discharging his duties. In the absence of the Secretary she/he can perform the duties of the Secretary.

TREASURER:

i) The Treasurer shall also maintain the accounts regularly and shall be in custody of the account books, vouchers etc. including the Bank Pass Book and Cheque Book.

ii) The Treasurer shall not pay out any amount exceeding sanction.

iii) No action of the Treasurer shall be binding on the Council or its Members or member.

iv) The Treasurer shall not credit any amount in his own account nor shall receive any money without issuing receipts therefor.

EXECUTIVE MEMBERS:

They are to do the work entrusted by the Chairman, Vice- President, Secretary, Treasurer and Governing Council in the matters related to the Society.

GENERAL BODY:

i) Annual General Body will meet once in a year i.e. in the first week of July.


ii) Functions:

- a) To pass the budget for the ensuing year and to approve the expenditure statement for the previous year.
- b) To approve the report of the activities of the Society.
- c) To select the Executive Committee and nominate the Educational Committee.
- d) To appoint an Auditor.

v) The Governing council shall consist of seven members (a) Chairman (b) Vice President (c) Secretary-cum-Correspondent (d) Joint Secretary (e) Treasurer and (f) Executive Members.

vi) The Governing Council, its powers and duties etc.

a) The Governing Council shall be responsible for the management and administration of the School/Colleges/Institutions established by the Society. The tenure of Office of the governing council shall be five years.

b) The Secretary shall convene meetings of the Governing Council atleast once in three months. He shall produce before the Council the reports of the Society, income and expenditure statements within 3 months at the end of the Financial year for approval of Governing council. In the absence of the Secretary the Joint Secretary shall have the powers to proceed accordingly failing which the Chairman shall have the powers to do so.

c) The Chairman or the Secretary shall have to convene a meeting of the Governing Council, if any three members of the Governing Council send a written requisition for the same.

d) Quorum : Half of the total members for general body meeting and 1/4 for executive body meeting.

e) The quorum for the meeting of the meeting of the governing council shall be (3) three. If a meeting is adjourned for want of quorum an adjourned meeting shall transact business without any reference to quorum, provided a written notice is sent to all the members of the Governing council.

f) Ordinarily notice shall be given for holding a meeting of Governing council three days in advance but for an extraordinary meeting 24 hours shall be deemed sufficient for emergent matters, circular meetings could be conveyed.

vii) There shall be an Education Committee to advise on the various methods to be adopted for best administrative/teaching techniques.

viii) The Governing council shall approve the estimated budget and accounts with the Audit Report.

FUNDS:

The funds shall be spent only to the attainment of the object of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.

BANKS:

i) Current Account shall be opened in any convenient bank at any places in the name of the Society and shall be operated by the Secretary or Chairman and for the convenience sake, the board may authorize/nominate any person to operate the bank account for day to day smooth functioning.

To this effect, Board may pass resolution.

ii) At the end of every year the accounts of the Society shall be audited by a Chartered Accountant appointed by the governing council.

iii) C.M.R. TECHNICAL EDUCATION SOCIETY shall be the sole owner of the movable, immovable property etc. of the society.

AMENDMENT:

The constitution of the institution shall not be amended except by a resolution adopted by an extraordinary General Body meeting convened for the purpose by the Secretary, at which not less than 2/3rd of the members of the Society shall present and vote, provided that no such meeting shall be convened unless notice of the proposed amendment is given to all members atleast two weeks before the date of meeting. And confirmed by 2/3rd of the members present at a second special meeting.

WINDING UP: In case of the Society is to be wound up, the property and funds of the society that shall remain after full satisfaction of the liabilities of the society, will be transferred or paid to some other institutions with similar aims and objects.
